EMERGENCY MEDICAL RESPONSE SYSTEMS

Emergency medical response systems provide the older adult who lives alone with a personal emergency system. The individual wears a pendant that can be activated by pressing a button in the event of an emergency. When the button is pressed, a signal is sent through the phone system to a manned base where the emergency is addressed.
